

Instruction to Authors

“International Journal of Wild Silkmoth and Silk” publishes articles concerning various aspects of silk-producing insects (or other organisms) and utilization of their silk. Manuscripts of original scientific reports, technical reports and reviews can be submitted. No manuscript that has been published elsewhere will be accepted for publication. Preliminary research reports of broad general interest may be submitted as ‘Scientific Notes’. Every paper will be peer-reviewed. Criteria for acceptance will be logical description and scientific merit of the contents.

Manuscript. The manuscript should be written in English. Members of the Japanese Society for Wild Silkmoths (JSWSM) may submit manuscripts written in Japanese. Submission as a form of electric files is acceptable. The text should be written with 12-point “Century” font (“bold mincho” in Japanese). Manuscripts should be submitted to:

It is recommended that papers are subdivided into the Title page, Abstract, Introduction, Materials and Methods, Results, Discussion, Acknowledgments and References.

1) Title page

The title pages should include the title, author’s name (first name, middle initial, last name), institutional affiliation, and mailing address of the corresponding author.

2) Abstract and Keywords

All papers (except Scientific Notes) must contain an informative Abstract and 3–5 relevant Keywords. Abstract must include the full scientific name of the organism(s), main objectives of the work, any new techniques, significant results and conclusions. It should be no more than 250 words in length.

3) Tables and Figures

Tables and figures should be numbered consecutively in Arabic numerals, e.g. “Table 1” and “Fig. 1”. Type each table and its caption on a separate sheet. Each table must have a descriptive heading and an explanatory legend. It is the author’s responsibility to submit images of sufficient quality for accurate reproduction. Each figure should have a descriptive legend which should be typed on a separate page.

4) References

Within the text, references to papers should be limited to the author and the year, e.g. (Akai, 1976) or Akai (1976). In the References, each citation must be complete, consisting of the author(s), year of publication, title, journal-abbreviated, volume and inclusive pages. Examples are as follows.

5) Conflict of Interest should disclose in the manuscript, if applicable, any relationships with for-profit entities that may have any interest in the subject matter or materials.

Reprints. A corresponding author will receive a PDF file of the paper free of charge. Reprints can be ordered at correction of galley proof. The cost is calculated by 40 yen × number of pages × number of copies.

Charges. Five thousand yen will be charged per manuscript as submission fee for non-members of JSWSM. Ten thousand yen for each color-printed page will be additionally charged in principle.
